HHC Minutes for Nov 14, 2006 meeting

B. Leadbetter moved that minutes be accepted, J. Cram seconds the motion

#### DOW COOPER SHOP:

H. Glover reported that at Selectmens meeting cooper shop was given to Kirsten Moriarty for her to remove, with HHC help.

K. Moriarty spoke on her initial interest in the cooper shop but explained that she now has to step away from the project.

Town needed to have insurance on people working to take down cooper shop but selectmen decided it wasn't prudent to sign such paperwork..

D. Ryder explained that the Building Inspectors point of view (in regard to cooper shop) was now public knowledge and if someone was hurt in the dismantling process the town would be liable. The town only carries ten thousand dollars worth of insurance per person. Also, if the cooper shop was not moved from its current location by 12/01/06, the town would have to pay to finish moving the building.

Mr. Gehan, who lives near the cooper shop, expressed an interest in having building moved to his land, but now that is not possible.

John Butler said No. Bennett Street School would like to take the cooper shop on as a project in the Spring, but that is also not possible now.

Owner of the cooper shop, Mr. Billingsly, will not extend the removal time of the cooper shop. However, he will allow John Butler on the land and in the cooper shop to take photos of the building. Butler would like the tarp off the roof and lattice removed from the windows before photographing. He said the Dow cooper shop is especially nice because it remains as it was. Has not been tampered with.

B. Leadbetter said a silk screening company offered to donate a drafting table if we could use it. The general consensus was that we cannot use it. B. Leadbetter will respond to offer, thanking them and declining offer.

Sign is done and company would like to install it. Sign can't go up until lights are moved. J. Cram will find out when lights will be relocated and let J. Lawrence know. We'll try to have Hollis Times on hand when the sign is put in place.

### **ROUND TABLE TALKS-L. Barbour:**

The HDC has the following Round Table Talks lined up: Landscape Architecture, Historic Architecture, and SPNEA (now Historic New England) will provide us with a discussion on Home Restoration.

L. Barbour reported that the library has provided the HDC with shelf space for reference manuals and has cataloged the material as well. Our commission should see about doing the same.

\$14,000. worth of work has been authorized for which we do not have the funds to pay for.

We need to find \$15,000. to \$23,000. to finish barn.

A big expense is the floor. Different floors are being researched.

New and used kitchen appliance options were discussed. If we can find a good used stove and refrigerator we would consider them.
